

COMMUNITY VOICE SURVEY FOUR 2019

This Summary Report presents the findings from Community Voice Survey Four 2019, conducted between 14 and 28 October 2019. Community Voice is an online panel of 487 residents who broadly represent the Glen Eira Community in terms of age, gender and suburb. The survey received 190 responses, a response rate of 39%.



SECTION ONE: COMMUNITY VISION

Council asked Community Voice members about your vision for the future of Glen Eira, and how you would like to be part of the process to develop a Community Vision. Your input will inform both the Community Vision, and how Council involves other community members in developing it.

Key findings

- The three things that respondents most commonly said they love about Glen Eira were: our natural and green environment; our sense of community; and our well designed, welcoming neighbourhoods.
- The three things that respondents most commonly said they hope for the future in Glen Eira were: quality, low rise housing; more green and open spaces and to be a leader in sustainability; and a sense of community.
- Respondents identified changes to the planning scheme and investment in green open space, waste reduction and climate action as key changes needed to bring about their vision.
- The three things that respondents most commonly said will make Glen Eira a
 great place to live in the future were: our community spirit and pride; our green
 environment; and an appropriate approach to development and population
 growth.
- The three things that respondents most commonly said will make Glen Eira a
 great place to work in the future were: our green, pleasant and safe
 environment; public infrastructure, services and amenities; and excellent public
 transport.
- The three things that respondents most commonly said would make Glen Eira a
 great place to play in the future were: our green, clean environment with parks
 and open spaces; recreation infrastructure; and diverse, friendly and safe
 community.
- The top five themes that respondents would be interested in exploring further
 with other community members were: public space; urban development and
 housing density; sustainability and the environment; sense of community and
 place; and social built infrastructure.
- Among respondents, the most popular ways of being involved in developing the Community Vision were: online, via Have Your Say; at community workshops; and pop up engagements.





1.7 Of the following themes, which five would you most like to talk about with other community members?





A group of randomly selected community members will then deliberate on all the feedback received and together develop a Draft Community Vision

document. The Draft Community Vision will be made available for public comment from April 2020 before being refined and presented to Council for endorsement in June 2020.


SECTION TWO: DRAFT PARKING POLICY

Council's City Futures team asked for Community Voice members' feedback on key aspects of the draft Parking Policy. This feedback will help Council understand the views of a representative group of residents.


Key findings

- The majority of respondents said that their households had either one (75, 39%) or two (88, 46%) cars.
- Most respondents (117, 62%) said that their household does not park any cars
 on the street at night. Just over one quarter (50, 26%) of households parked one
 car, while a small proportion parked two cars (15, 8%), or more than two cars (6,
 3%) on the street overnight.
- Many respondents said that they, or their visitors, sometimes (82, 43%) or often (50, 27%) find it difficult to find a car park near their house. The most common reason given for this difficulty was that the available car parks were being used by other residents.
- A significant number of respondents said that they often (89, 47%) or always (15, 8%) have difficulty finding a parking space when visiting local businesses/shops.
- Most respondents agreed or strongly agreed that the proposed neighbourhood approach was fair and reasonable for resident car owners, the wider community and for achieving a more sustainable transport future.
- Overall, respondents were supportive of the proposal to offer a \$100 Myki card
 to eligible households that forgo access to a parking permit. 80 respondents
 (43%) rated this as a "good idea", compared to 39 (21%) who rated it as "not a
 good idea".
- A majority of respondents felt that it is very important (112, 60%) or important (57, 30%) that Council has a policy to manage parking across Council.


2.1 How many cars does your household own?




2.2 How many cars does your household usually park on street at night?






2.5 When you travel around Glen Eira, how often do you experience the following issues?

Together, these factors would inform a draft Neighbourhood Parking Plan, which would be subject to residents' feedback. Overall, what do you think of this approach?



2.7 Neighbourhood Parking Plans would also consider the presence of key landmarks. Areas around 400 metres of landmarks that generate parking demand would attract parking restrictions (and access to permits by residents) to manage street use and help to disperse parked vehicles. "It seems a good idea if neighbourhood aspects are taken into account but are not determinative. I suspect that making a street by street decision is to some extent unavoidable." (Male, 50-59, Glen Huntly)


"My concern is that commuter parking is lowest priority. Travelling by public transport in winter - or bad weather- or returning late at night, many of us only do this by taking the car to the station car-park - otherwise we do not go out in these conditions, particularly to the theatre precinct near Flinders st. I think that there needs to be an increase in train station parking for the use of all the new residents planned, current car parking at train stations is close to capacity now." (Female, 60-69, Elsternwick)

"With higher density living becoming the norm and parking within the higher density accommodations being designed poorly by developers, there are so many cars in the streets looking for parking spots it is unsustainable. Each household can have 2-3 cars in the streets and they may have only one parking spot provided. It is a nightmare now. How will council improve this, is my question to you." (Female, 60-69, Carnegie)


"The thing about myki is not an incentive and confusing. But if you could park on a nearby street not just your own if you can't find one that's useful and good." (Male, 25-34, Glen Huntly)

"To also consider other factors, for example, there is no safe bike lanes on our street or 'neighbourhood' and we live near a station. So whilst the station will be considered as it will increase demand for parking, there is no incentive for people to use the more sustainable approach of riding to the station as it is very dangerous with no bike lanes and dense vehicle usage around peak times." (Female, 25-24, Glen Huntly)


2.9 The draft Policy proposes a change to the number of permits a household can access, depending on access to public transport in the area. In areas of Glen Eira where public transport access is low, eligible households would be able to access three permits. In other areas, households would be able to access two. Eligible households who do not have off-street private parking would be able to access an additional parking permit. Do you agree that this approach is fair/reasonable for Glen Eira?






2.11 The draft Parking Policy includes some changes to the way permits for visitors are provided and managed. Under the new approach, an eligible household would be able to access 50 daily use visitor permits per annum at no cost and another 50 for a total fee of \$50 (or free for pensioner/concession card holders), allowing a total of 100 daily use visitor permits per year. These visitor permits would be over and above the maximum residential permits an eligible household would have access to. Do you agree that this approach is fair/reasonable for Glen Eira?

"I'm dubious about charging for parking permits for residents. While we don't have parking issues in our area, our house has 5 adult residents and four cars with no real off street parking (other than in our back yard). The cars are used to get to work, one a tradesperson, one that works quite a distance making public transport unviable, and another that works at different locations, again making it unviable to use public transport. The 4th car is shared between the other 2 adults for shopping and other uses. This scenario could easily apply in an area of high demand parking and it seems unfair as a rate payer to have to pay more to park your cars. I think the council is going to receive a fair amount of push back on charging for parking permits." (Female, 50-59, Murrumbeena)

"Make sure public transport can be accessed by everyone. For example I would love to use it to go to drop off at school but trams are Not stroller friendly on my route. There are small changes that could be done to support people using public transport rather than punish them to force them to use it" (Female, 25-34, Caulfield)

"Most of this sounds really sensible, but I feel it would need more tailoring to the needs of seniors, people with disabilities or other special needs (e.g. babies, carers who visit, etc.)" (Female, 35-49, Carnegie)

"permit fee should also be reduced for holders of a healthcare card." (Male, 35-49, Glen Huntly)

"Given the council wants to encourage residents to use off-street parking, it becomes important that multi-level developments must provide parking facilities for their residents." (Male, 50-59, Elsternwick)

What will Council do next?

Glen Eira's City Futures team sought feedback from Community Voice to understand how a representative group of residents viewed key components of the draft Parking Policy, including proposed changes to permits, and moving to a neighbourhood approach to review parking arrangements.

The views shared by Community Voice members enable us to interpret those that have been shared by the wider Glen Eira community, helping us to hear from a more diverse group of residents.

We were interested to know that most Community Voice members consider it either very important or important that Council has a policy to manage parking and that most members agree or strongly agree that the proposed neighbourhood approach and changes to parking permits are fair and reasonable to car owners, the wider community and for achieving a more sustainable transport future.


Our next steps will involve carefully reviewing, assessing and making revisions to the draft Parking Policy with reference to what we have heard from Community Voice and the wider community. A community feedback report will be produced and the City Futures team will work through it, together with other colleagues from different teams.

A revised Parking Policy that takes into account the feedback we have received will be presented to Council for consideration and a decision, early next year.



DRAFT PARKING POLICY

Council recently released a <u>draft Parking Policy</u>. The aim of this policy is to ensure that the rules around parking remain fair and effective, even as our population grows.

Alongside Greater Melbourne, the population of Glen Eira is growing. State government policy ensures that population growth is shared across the metropolitan area. Here in Glen Eira, Council needs to plan for this growth, including how it will affect parking. Using a car is important to many people's lives and will continue to be so. We also know that encouraging and supporting alternative modes of transport will help to reduce congestion, and keep our neighbourhoods livable.

Parking in our neighbourhoods

Currently, changes to parking are considered on a per-street basis, following the expression of concerns by residents and an investigation by Council. This approach tends to be reactive (i.e. waiting until concerns or issues arise), inconsistent and not as strategic as it could be. As a result, rules can vary between streets and don't directly take into account features of the surrounding area and aspects such as projected growth that could affect parking conditions and requirements.

One of the key proposals in the draft Parking Policy is to shift away from deciding parking conditions on a street-by-street basis, towards a more systematic 'neighbourhood approach'. A neighbourhood approach looks at parking conditions and requirements across a defined local area (usually between key roads).

6. Our neighbourhood approach would involve taking into account the planning zone and access to public transport in the local area. Together, these factors would inform a draft Neighbourhood Parking Plan, which would be subject to residents' feedback. Overall, what do you think of this approach?
