

Community Voice Summary Report - Survey Three, 2018

The following summary report presents the findings of the second Community Voice survey, held from 22 August to 5 September 2018. Community Voice is an online group of **456** residents that represent the broader Glen Eira community in terms of age, gender, and suburb. We received **262** responses to the survey, giving us a 58% response rate.

The below graphics show the number of survey respondents (shown in teal) versus the number of Voice members (shown in blue).



SECTION ONE: NEIGHBOURHOOD CONNECTIONS


Council endorsed a new Community Safety Plan in June 2018. One initiative in the Plan is to explore ways to strengthen connections within neighbourhoods. This section sought feedback on experiences of neighbourhood connections, as well as views on a range of different initiatives Council could support.

To assist responses, Community Voice members were asked to consider (for the purposes of the questions) 'neighbours' to be those living in close proximity and 'neighbourhood' to be the street and surrounding streets.

KEY FINDINGS

- There are almost universal feelings of safety during the day
 - 92.4% of participants (242) felt 'safe' or 'very safe' walking alone in their local area during the day. The largest group of participants (182; 69.1%) felt 'very safe'.
- Just over half participants felt safe after dark
 - 53.1% of participants (139) felt 'safe' or 'very safe' walking in their local area alone after dark. 20.2% (53) felt neither safe nor unsafe. 56 (21.4%) felt either 'unsafe' or 'very unsafe'.
- **Most agree/strongly agree** that people in their neighbourhood are willing to help their neighbours (61.1%; 160) and can be trusted (56.5%; 148). When asked if theirs was a close neighbourhood, 38.9%;102 neither agreed nor disagreed.
- Most participants (69.5%; 182) know their neighbours well enough to ask for help if needed
 - o 16.4% (43) have met their neighbours but don't think they could ask.
- Most participants (81%; 213) take part in at least some activities that connect them to neighbours
 - \circ 43.1% (113) not so often, and 25% (66) somewhat often.
- Participants were most in favour (50%; 133) of an initiative such as Sunday Streets where streets are closed to through traffic for a day to have a street party for residents.

Q1.1 How safe or unsafe do you feel when you are in the following situations?



Q1.2 How would you describe the general feel of your neighbourhood? Do you agree or disagree that:




Other responses included that 'some' neighbours are known well, others are not, and that participants would prefer not to have to ask their neighbours for help.

What will Council do next?

The Neighbourhood Program Working Group – a sub-group of the Community Safety Committee – is currently working on a number of projects to help residents of Glen Eira connect with each other. The responses we've received through this survey have provided us with some insight into the sorts of activities that would be popular with the community.

We're currently investigating a Council membership for the nation-wide Garage Sale Trail program, with the aim of facilitating and encouraging local residents to sign up to the program for 2019. The Garage Sale Trail program has become increasingly popular across the country, and is held on one weekend each October. The program not only encourages people to get out and about in their communities and meet other neighbours by visiting a number of garage sales over the weekend, but has been instrumental in reducing waste that would otherwise go to landfill. Through this survey you told us that a Sunday Streets program was the main initiative you would like to be involved in to help you better connect with your community. As a result, Council is planning to pilot this program in four locations (locations yet to be determined) with the aim of improving neighbourhood connections at a street level. The program has been endorsed by Community Safety Committee, and we hope to able to provide you with more information in due course.

Coming up on 31 March 2019 is Neighbour Day. Next year's theme is *Loneliness: What neighbours can do to create connections*. There will be events arranged for this by Council and by local community groups. Keep an eye out in Glen Eira News and on the Glen Eira website for more information closer to the date.

SECTION TWO: AFFORDABLE HOUSING


Council is in the process of exploring potential actions to facilitate the creation of social and affordable housing in Glen Eira.

State Government funding has been received to develop a Social and Affordable Housing Strategy. The questions in this section sought thoughts and ideas on this topic in preparation for the development of the Strategy.

KEY FINDINGS

- The majority of Community Voice considered affordable housing to be a significant concern in the Glen Eira community
 - 33.6% (88) thought this issue was a significant concern affecting some, 28.6% (75) that it was significant concern affecting many
- Community Voice members provided their impressions of their local neighbourhood and the community as a whole, discussing their views on **housing costs**, the nature of the Glen Eira community, their concerns for particular cohorts (young people, young families, new arrivals, older people, people experiencing homelessness) and suggestions for future actions.
- **'Dwellings for older people'** was the most commonly selected (by 178, 67.9%) option for housing types that Glen Eira should focus on in the development of a new Strategy
- Participants rated supporting Glen Eira residents experiencing housing stress and homelessness as the most important action for Council
 - o 211 participants or 80.5% rated this option as 'important' or 'very important'



'Of the options above, I believe Council should focus on those that are most likely to increase housing affordability in the short term e.g. focus on existing areas and initiatives rather than lobby the government for more areas or initiatives. These other avenues are important in the long term but I can't see them helping in the short term'. (Female, Bentleigh, 35-49 years)

What will Council do next?

At its meeting on 4 September 2018, Council endorsed a Statement of Commitment on Affordable Housing:

Statement of Commitment

Council commits to:

- 1. Developing a Social and Affordable Housing Strategy to outline Glen Eira's housing and service need of our most at-need groups in Glen Eira.
- 2. Taking a whole-of-Council approach to supporting Glen Eira residents experiencing housing stress and homelessness.
- 3. Advocating to the State Government to provide affordable housing on governmentowned sites in Glen Eira.
- 4. Collaborating with other councils to seek a consistent minimum level of affordable housing on larger development sites.
- 5. Negotiating for on-site affordable housing opportunities through the rezoning process for strategic sites.
- 6. Partnering with housing associations and providers to increase the overall supply of affordable housing on Council's existing housing sites, where appropriate.
- 7. Actively explore the inclusion of affordable housing in the redevelopment of Council owned sites.
- 8. Advocating to the State Government for planning controls that facilitate affordable housing

We're now developing a discussion paper that we hope to release to the community for comment early next year. Following that period of consultation, a draft Social and Affordable Housing Strategy will be developed.

The feedback you have provided in this survey will help us in the development of the discussion paper and subsequent Strategy. We will let you know when the discussion paper is out for community feedback, and we encourage you to take part in that consultation.

SECTION THREE: HEALTH AND WELLBEING ACTIVITIES


A new action plan has been developed for Council's Municipal Public Health and Wellbeing Plan 2017-2021. This section sought preferences on the types of activities that will form part of a program of events to help deliver the new action plan.

KEY FINDINGS

- The most highly rated topic for a wellbeing seminar was 'Understanding anxiety', selected by 50.4% (132) of respondents
 - 'Stress management' and 'Mental health myth busting' were also rated highly as second and third most selected topics
- Community Voice would most like to see yoga as the activity run at Active Parks, with this option selected by 56.5% (148) of respondents
 - Pilates and Tai Chi were also rated highly as second and third most selected activities


Q3.1 Council's program of events will include a series of free wellbeing seminars. Which of the following topics would you be interested in seeing these seminars cover?

What will Council do next?

The responses we've received from this section are being used by Council officers to plan activities to implement as part of the Municipal Health and Wellbeing Action Plan 2018-2020.

The Active Parks program for 2018-2019 is being planned, and will also be promoted through the above channels. These programs will be advertised in each edition of Glen Eira News between October 2018 and March 2019.

SECTION FOUR: RECOGNISING VOLUNTEERS

This section sought views about Council's role in recognising volunteers in Glen Eira, to support the review of the Volunteer Recognition Program.

To support responses, participants were advised to consider 'volunteering' (for the purposes of the questions), as involving contribution of time free of charge for a community group or organisation in any role.

KEY FINDINGS


- There are high levels of current volunteerism within Community Voice
 - In total, 32.4% of respondents (85) currently volunteer (either regularly or every now and again) for an organisation serving the Glen Eira community
 - 23% of respondents (70) currently volunteer for an organisation serving a different community
- Half of all respondents (131) have at least heard about Council's current volunteer recognition program (but only 6.5% 17 have participated)
 - o 48.5% had not heard about the Program
- The most popularly selected option for public acknowledgement of volunteers was an open public event (selected by 101 or 38.5%).
 - Responses provided in comments suggest however, that many participants would have liked to select more than one option, for the different purposes each could serve.
- While there were divergent opinions amongst respondents on recognising volunteers, there was **significant support for what volunteers do** and many suggestions made for raising awareness, acknowledging contribution and increasing participation.



In 2016, the ABS National Census found that in Glen Eira, 21.3% of the population 15 years and over reported doing some form of voluntary work in that year. This is higher than the 17.6% across Greater Melbourne.

Illustrative quotes

'I would actually support options 1, 3 and 4 above. Not enough is done to encourage, publicise or recognise these people' (Male, Elsternwick, 60-69 years)

'Create a Glen Eira Hall of Fame...volunteers now and in the future...' (Male, Bentleigh East, 50-59 years)

'I like seeing volunteer profiles in the Glen Eira paper and on social media platforms, it's a good way of recognising these people (with their permission of course) and will encourage people to think about volunteering themselves. I think volunteers deserve a formal official celebration'

(Female, Caulfield North, 25-34 years)

'An open public event would provide the most publicity for volunteering groups and hopefully encourage more participation or at least more interest'. (Male, Murrumbeena, 18-24 years)

I don't agree with a public acknowledgment of volunteers in the way of newspaper articles or civic ceremonies. Volunteering should be a community expectation' **(Female, Caulfield North, 60-69 years)**

What will Council do next?

The information provided to us through this survey has given us some great feedback that will help us to review the ways we recognise volunteers, and promote volunteerism throughout the community. The results have shown that volunteering is strong in our community. Council is now working to develop a framework for volunteering in our community to enhance volunteering within Council to increase community participation.


In the next Community Voice survey (due out in mid-November) we will ask you for your views on the development of this framework for volunteering. The responses you give will help us to draft the framework, ensuring that its content is reflective of community.

SECTION FIVE: FOLLOWING UP ON FOOD WASTE RECYCLING

Following implementation of the food scrap recycling service, this section sought to check in with Community Voice on implementation of the service so far, to assist in reviewing Council's performance.

KEY FINDINGS

- The majority of survey participants (168; 64%) are using the food scrap recycling service
 - While 34% (90) indicated they were not, many of these respondents are home composting, planning on taking up the service or would like to but currently cannot (due to residence within an apartment complex)
- Feedback from Community Voice members is **very positive**, with those using the service noting a significant decrease in red bin content and many people feeling satisfied to be reducing their waste to landfill
- Some Community Voice members have noticed odours, some haven't
- Many would like a transition to a weekly pick up service both for issues of odours and because the green bin is being used more than the red bin

122 participants provided a response to this question. The main themes are listed below:

What You Said:

'I think it's fantastic! It's reducing the amount of waste in our red bin. I haven't noticed any odour/pest issues with the bin being collected once a fortnight (versus once a week in the red bin). Our next step will be to install our own worm/waste farm - some councils have deals on these types of products - that would be fantastic.' (Female, Elsternwick, 25-34 years)

'I like the idea and we use it but it does make our green bin very dirty and smelly. I wish there was a solution to that problem.' **(Female, McKinnon, 60-69 years)**

'I have found the scrap caddy very easy to use in the kitchen for catching all the food peelings etc. that I would otherwise put to landfill. It now all goes into the caddy and then into the green bin.'

(Male, Bentleigh East, 60-69 years)

Q5.3 If no, why not?

90 respondents provided a response to this question. The main themes are listed below:

'I think that placing meat scraps and bones in green waste is unhealthy and attracts vermin especially in waste centres and local housing.' **(Male, Bentleigh, 70-84 years)**

We have a. Compost bin at home that all out food waste goes into.' **(Female, Bentleigh East, 18-24 years)**

'Because I live in a flat with private waste collection, although I'd like to be part of it regardless and think flats should be involved'. (Female, Bentleigh, 35-49 years)

What will Council do next?

There are a number of ways that Council is monitoring the ongoing success of the food waste recycling program; seeking your feedback over a period of time is one of them. In future surveys, we will be asking you for feedback on key waste issues, such as recycling contamination and understanding what can and cannot go in your recycling bin.

In November and December, Council will be using a variety of methods to gather feedback from the whole of the Glen Eira community on how the program is being received, and will also being asking the community questions about the frequency of our waste collection service.

We will let you know when this consultation is live so that you can participate in it. We will also be asking you some more questions through Community Voice about the service and the frequency of collections in coming months.


SECTION SIX: YOUR FEEDBACK AND IDEAS ON COMMUNITY VOICE

This section sought to check in with Community Voice members on their experience with the process so far and their ideas for Community Voice.

KEY FINDINGS

- The majority of participants (64.9%, 170) found their experience of Survey Three to be satisfying, however:
 - % satisfaction has fallen from Survey One (77.7%) and Survey Two (66.7%)
- The majority of participants (85.1%, 223) thought that the length of Survey Three was about right
 - % who considered length about right has fallen from Survey Two (86.0%) but is higher than Survey One (78.4%)
- The largest group of participants provided comments to the effect that they were happy so far with the survey, however there were suggestions made for the survey structure (not enough flexibility and options in layout) and content (topics should be more relevant, such as planning, traffic, neighbourhood design)
